## Limited Review Report

To

We have reviewed the accompanying Statement of Standalone Unaudited Financial Results of AMRAWORLD AGRICO LTD. ("the Company"), for the Quarter ended June 30, 2018 ("the Statement"), being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as modified by Circular No. CIR/CFD/FAC/62/2016 dated July 5, 2016.
